<b>ENTRY FEE/DUE:</b>	<b>\$20.00 if received in FAIR OFFICE <i>no later</i> than 5:00 p.m. on Thursday, March 28, 2019</b>
<b>LATE ENTRY FEE/DUE:</b>	<b>\$25.00 FEE CASH ONLY accepted until 10:00 a.m. on Saturday, March 30, 2019</b>
<b>JUDGING:</b>	<b>Saturday, March 30, 2019, 11:00 a.m.</b>

1. Acts can be musical talent of amateur status. Definition of a professional is: *Either all or part of a group or individual who is paid for professional entertainment in the respective talent.*
2. All acts must be 2 - 4 minutes from the time the actual talent begins. Points will be deducted if time limit is not followed.
3. No guns, knives, sharp objects, fire, smoke or smoke effect(s) will be allowed on stage during the Talent Contest.
4. Vocal talent will be given point deductions for singing over words on music. Deductions at discretion of judges.
5. No profane language allowed. No misconduct. Unsportsmanlike conduct of contestant, parent or instructor will result in elimination.
6. Spectators may not stand or sit in front or directly behind judges during performances.
7. Photographs cannot be taken in front of judges or directly behind judges during performances.
8. All decisions of the judges will be final.
9. Music must be on a **CD or FLASH DRIVE in a MP3 FORMAT.**
10. Only the contestants are allowed free admission the day of the Talent Show.
11. Talent Show contestants must check in with Talent Chairperson at given times. If contestant is not present 15 minutes before respective category begins, contestant will not be eligible to complete and no refund will be given.
12. Each category must have at least 3 contestants. If not, contestants will be placed in a category closest to their age group at the decision of the Talent Chairperson.
13. Age groups and categories/divisions are listed below. If talent is a group, division will be determined by the average age of group.
14. Talent will be judged on Showmanship/Crowd Appeal, Originality, Overall Performance with a total of each category on a scale of 1-5 (5 being highest max for each category) and Talent with a total of this category on a scale of 1 – 10 (10 being the highest max). The highest possible score per judge is 25. In case of a tie judges will break the tie.
15. Every contestant and parent if minor must complete an Indemnity form and follow all rules. GCF&R, Inc. and Talent Show committee reserve the right to amend rules as necessary, as well as accept any entry desiring the participation in Talent Show. Failure to follow all written and verbal rules and regulations can constitute grounds for non-participation of current year GCF&R Talent Show. Entry form must be completed fully before contestant is officially entered in contest.
