## Gingerbread House Contest Rules

| <b>AGES:</b>        | All Ages: Family/Group, Sub-Junior (8-12), Junior (13-17), Adult 18 or older                                |
| <b>ENTRY FORMS:</b> | Entry forms are due in the Fair Office by 5:00 p.m. Tuesday, November 29, 2022                              |
| <b>DROP OFF:</b>    | All Gingerbread Houses/Structure must be dropped off from 3:00 p.m. - 5:00 p.m.<br>Friday, December 2, 2022 |
| <b>JUDGING:</b>     | Judging will begin at 6:00 p.m. Friday, December 2, 2022  |

1. All Gingerbread house/structure entries must be made with **Graham Crackers (NO KITS)** and be a recognizable house/structure.
2. All Gingerbread houses/structures must be placed on a sturdy cardboard base not to exceed 18"x18".
3. All Gingerbread houses/structures must be 100% edible, candy/embellishments/materials except the base board and candy wrappers. Non-edible support structure material other than the base board may not be used.
4. No artificial interior materials, such as Styrofoam, are to be used to construct or decorate the house/structure.
5. Non-edible decorations, such as paint, ribbon, figurines, etc. may be used **ONLY** to decorate your base.
6. **A list of materials used to create your Gingerbread House/Structure along with a title and a brief description should be submitted with your entry or your entry will not be accepted for judging.**
7. Completed entries forms must be submitted to the Galveston County Fair Office no later than 5:00pm Tuesday, November 29<sup>th</sup>.
8. All Gingerbread Houses/Structures must be dropped off between 3:00pm to 5:00pm Friday, December 2<sup>nd</sup> in Ed Pickett Hall in the Country Store. Judging will be at 6:00 p.m. and the winner will be announced after the Christmas Tree Lighting. Approximately 7:00 p.m.
9. Items may be picked up on Saturday, December 3<sup>rd</sup> from 1:00 p.m. to 2:00 p.m. All entries left past 2:00 p.m. will be disposed of.
10. All entries will be judged on the following: Overall appearance, Creativity, originality and technique & skill.

### GINGERBREAD HOUSE/STRUCTURE TIPS AND RECIPES

- A. Icing is the glue that holds the gingerbread house/structure and materials together. The icing should be stiff enough to work as a glue and hold its shape, but flexible enough to spread easily.
- B. If you would like to color your icing, use paste food coloring. Liquid food coloring will thin out the icing. Keep a moist towel over the mixing bowl to keep the icing from hardening.
- C. Let Icing dry completely. If your icing is soft the walls and roof will slip and slide around when you add candy and decorations.

#### **Royal Icing Recipe 1**

3 tbsp. Meringue powder  
4 cups sifted confectioners' sugar  
6 tbsp. water  
Beat all ingredients at low speed for  
7 to 10 minutes, or until icing forms peaks

#### **Royal Icing Recipe 2**

3 cups confectioners' sugar  
¼ tsp. cream of tartar  
2 egg whites, beaten  
In a bowl, sift together confectioners'  
sugar and cream of tartar. Using  
Electric mixer, beat in 2 beaten egg  
Whites for about 5 minutes or until  
Mixture is thick enough to hold its shape
