\$25.00 due with entry if received after February 21, 2019 – SORRY, NO REFUNDS! All entries must be received in the Fair Office by 5:00 P.M. on Thursday, March 7, 2019. No entries will be accepted after this date.
JUDGING: Contest will be held on Saturday, April 6, 2019 at 10:00 a.m. at the Galveston County Fair & Rodeo Entertainment Pavilion

Sponsors for the event are needed. Sponsors will be recognized in the program and during the event.
Those interested in helping sponsor the event with a cash donation to be used for trophies or gifts for the winners should check the box on the attached entry form.

Trophies are not awarded to all contestants, please see rule # 10. If you are interested in purchasing a trophy to give to your child, the cost is \$8.00. This fee must be paid in advance and must be received by February 21, 2019.

1. Baby Cowboy and Baby Cowgirl contestants must be ages 0 – 2 as of the date of the contest.
2. Contestants will be required to submit an Emergency Medical and Indemnity Form with their entry form. Failure to do so will result in the disqualification of the contestant.
3. A recent photograph of the contestant must be submitted with the entry form. **This photograph will be published in promotional materials for the Fair. (NO GLAMOUR SHOTS ACCEPTED.) Entry must be submitted by February 21, 2019 to be published in the promotional materials.**
4. The contestant's parent(s) or guardian(s) agree with the Galveston County Fair & Rodeo, Inc. that the contest is for the purpose of extending an opportunity for the contestants to participate in a good experience and fun event. Each contestant is expected to act properly and to present a good image.
5. Contestants will be judged the day of the event on personality, attire and poise. Baby contestants will not have a separate interview; each will be accompanied on stage by one adult and come to the center of the stage. At this time, the child should smile, be cute, show his/her personality, charm the judges, etc.
6. Contestants' parent(s) or guardian(s) agree the time, manner, and method of judging shall be within the discretion of the Galveston County Fair & Rodeo, Inc. and the decision of the judges in final. If you would like a copy of your score sheet (s) mailed to you, please turn in a self-addressed stamped envelope the day of the Contest and they will be mailed to you the following week.
7. Only the contestants are allowed free admission the day of the Contest.
8. **One boy will be named Baby Cowboy and one girl will be named Baby Cowgirl. There will also be awards for 1st and 2nd runner up in each category, a Congeniality Award and a Best Dressed. EACH CONTESTANT WILL ONLY BE ALLOWED TO WIN IN ONE CATEGORY.**
9. A **parent and contestant** meeting will be held Thursday, March 7, 2019 at 6:30 p.m. in the Youth Building located at the Galveston County Fairgrounds.
