**CROWNING:** Thursday, April 20, 2023 at 6:30 pm in the Rodeo Arena

**PARADE:** Saturday, April 8, 2023 at 9:00 am at the VFW Post 5400 in Santa Fe

1. The Galveston County Fair King Contest is open to all boys who meet the following requirements:
  - a. are registered in the 9th thru 12th grade of a public or private school in and are members of a Galveston County 4-H or FFA Chapter;
  - b. is not a former Fair King of Galveston County Fair;
  - c. is single and has never been married;
  - d. has a project entered in the Galveston County Fair through 4-H or FFA, including:
    1. an animal project(s) (Livestock entries due January 26, 2023)
    2. OR has eight (8) items entered in the Youth Project Show (Project Show entries due February 23, 2023)
  - e. Winner must be present to ride in **2024** GCF&R opening day parade.
2. Each contestant must meet the eligibility requirements set by their school. A Declaration of Eligibility Form will be sent to the contestant's school for verification of eligibility. Eligibility Forms will be handled by the Fair Office. You will be notified by the Chairperson if you are **not** eligible to compete. Refer to GCF&R Eligibility Rules.
3. Each Fair King is responsible for getting their own sponsor and must bring a thank you note to the interview, stamped and addressed to their sponsor. **The thank you card must be given to the chairperson to mail before credit will be given.** No exceptions, points will be deducted if not turned in. **THE ENTRY FEE IS \$50.00** which is to be paid by the sponsor. The deadline for entry forms and entry fees will be **THURSDAY, FEBRUARY 23, 2023, BY 5:00pm IN THE FAIR OFFICE. NO ENTRY FEES OR FORMS WILL BE ACCEPTED AFTER THIS DEADLINE. NO REFUNDS FOR ANY REASON. ALL RULES WILL APPLY AS OF ENTRY FORM DUE DATE.**
4. A personal narrative will be completed by each contestant. Write and attach a narrative no less than 1 page and no more than 2 pages in length about yourself, pointing out important facts about yourself. Also include community service and why you are the best candidate to represent the fair. Each contestant must attach a 3 x 5 photograph to their entry. This photograph will be published in promotional materials for the fair, and will not be returned.
5. All contestants are **required** to ride in the Parade on **Saturday, April 8, 2023**, to "kick off" the Fair. Contestants should assemble at 9:00 a.m. at the VFW Post 5400 Parking Lot on Hwy.6 in Santa Fe. Western wear will be the attire for the parade. You are not required to provide your own vehicle, a vehicle will be provided for all contestants to ride in.

6. There will be a **MANDATORY PARENT AND CONTESTANT** meeting on **Tuesday, March 28, 2023, at 7:00 p.m.**, in Youth Building. **ATTENDANCE IS MANDATORY. (Exception - Death, illness or UIL Function. Chairperson must be notified in advance in order to be excused or you will not compete.)**
7. A private interview with the judges will be held on **Tuesday, April 4, 2023**, with assigned times beginning no later than 7:00 p.m. Western wear will be the attire for the interview. Contestants will be judged on poise, personality, appearance, projects and achievements, participation of shows and scheduled work hours and essay, questions and interview. The crowning of the King and his Court will be on **Thursday, April 20, 2023** at 6:30 pm in the Rodeo Arena.
8. All contestants will be furnished with a schedule of events and dates. **All contestants are required** to be at designated events during the Fair. The designated events will be determined by the Fair King Chairperson. A form will be provided and upon completion of show, initialed by each show chairperson. **The King is required to ride in the Grand Entry at the Rodeo on Friday and Saturday night. Also, It is MANDATORY that the King be in attendance at the Commercial Heifer Show, and at the Junior/Little Fair & Rodeo Crowning, Friday, April 21, 2023. He must also be in attendance at the Baby/Tiny/Lil' Cowboy/Cowgirl contest and the Commercial Heifer Auction on Saturday, April 22, 2023.**
9. The decision of the judges is final. Under no circumstances shall contestants attempt to contact the judges before or after entering contest.
10. The contestants will vote for a Mr. Congeniality. This should be the boy who is always happy, helpful, and never complains. Contestants are not allowed to vote for themselves.
11. Each participant is **required** to sign an Emergency Medical & Indemnity Form attached to the Entry Form. Failure to complete these forms will result in disqualification.
12. All contestants are **required** to wear their badges at **ALL** times on the Fairgrounds **EXCEPT** during any show in which you participate as an exhibitor. Badges will be provided for all contestants.
13. ***A No Tolerance policy will be enforced. Each contestant must set a good example for their peers. A POSITIVE ATTITUDE AND BEHAVIOR IS A MUST. Remember you are representing your family, 4H, FFA, school, city, county and the Galveston County Fair & Rodeo. Absolutely no unsportsmanlike conduct. FAILURE TO COMPLY WITH THIS RULE MAY RESULT IN DISQUALIFICATION FROM PARTICIPATION IN THE GALVESTON COUNTY FAIR & RODEO, INC. FOR THE CURRENT YEAR IN WHICH THE VIOLATION OCCURS AND THE FOLLOWING YEAR. THE EXHIBITOR WILL FORFEIT ALL AWARDS AND/OR PROCEEDS.***
