**NOSE PRINT, TAG-IN &**

**TOOTHING:** Saturday, December 05, 2020, 9:00 a.m. to 10:30 a.m.

**ENTRIES DUE:** All entries must be submitted online by January 28, 2021. Entry fees are to be turned into your 4-H Leader or Ag Teacher

**CHECK-IN:** Saturday, April 17, 2021, 11:00 a.m. to 1:00 p.m. Livestock Barn South Gate

**WEIGH-IN:** Weight Cards must be submitted to the check-in no later than 2:00 p.m. on Saturday, April 17, 2021

**SIFTING:** Minimum of 100 pounds weight

**JUDGING:** Sunday, April 18, 2021 @ 11:00a.m.

**ENTRY FEE:** \$25.00

**RELEASE:** Sunday, April 18, 2021, 3:00 p.m. All Lambs will be released At 3:00 p.m. or immediately following the show – Livestock Barn South Gate

**MAY1, 2021:** Market Lambs that sold in the Jr Auction or by Commitment must return to the 8:00 a.m.-10:00 a.m. fairgrounds to be picked up by packer Livestock Barn South Gate Lamb/Goat Area

1. All entries for this division will be subject to the General Livestock Rules of the Galveston County Fair & Rodeo, Inc. except where they conflict with the requirements of this division in which case the division rules will prevail. In the event of special circumstances that may arise, or a conflict between rules, decisions of the Show Chairperson and the Livestock Superintendent will be final.
2. All lambs will be tagged-in, nose printed, and toothed on Saturday, December 05, 2020 from 9:00 a.m. to 10:30 a.m. at the Fairgrounds. Lambs will be toothed on date of tag-in. Lambs must have both central temporary incisors in place with no permanent incisors showing when toothed.
3. Lambs must weigh not less than 100 pounds at check-in, Saturday, April 17, 2021. All Market Lamb will be weighed by the exhibitor on the designated scales provided by the Lamb Committee. Each exhibitor must return the weight card to the official check-in table no later than 2:00 pm on Saturday, April 17, 2021. The weight card is the **INDIVIDUAL OFFICIAL WEIGHT**. Once the weight card is turned in, absolutely no changes can be made. **NO EXCEPTIONS**.
4. Each exhibitor is entitled to enter and show two (2) lambs in the 2021 Galveston County Fair, either ewe or wether lamb. Entries must be submitted online by January 28, 2021. Further instructions will be sent to your 4-H Leader/Ag Teacher when these forms become available. All Exhibitors will turn in the entry fees to the 4-H Leader/Ag Teacher of the club/chapter they will be exhibiting under.
5. Bedding (shavings) will be allowed in lamb pens at exhibitor's expense. Exhibitor's shavings cannot be stored on the fairgrounds.
6. **Absolutely no tying of lambs allowed in pens. Lambs must remain in assigned pens unless authorized by the Lamb Chairperson or Livestock Superintendent to be moved to a different pen.**

7. No paint or colored powders are allowed. "BLOW DRYERS" WILL BE ALLOWED TO BE USED ONLY AT THE POWER PLANT.
8. **All lambs MUST be shorn 3/8" or less PRIOR TO ARRIVAL on Galveston County Fair & Rodeo, Inc. Grounds. NO CLIPPING OR TOUCH UPS AFTER ARRIVAL WITH ANY (ELECTRICAL OR MANUAL, SCISSORS, RAZORS, KNIFE, ETC.) APPLIANCES.**
9. Exhibitors are responsible for feeding and watering their lamb and keeping the stall and lamb barn area clean at all times. There will be **NO FEEDING OR WATERING IN THE LAMB PENS.** Failure to comply, as determined by the Lamb Chairperson and Livestock Superintendent, will result in removal of the animal from the Fairgrounds, forfeiture of all prizes and awards, and/or further disciplinary action as deemed appropriate by the Galveston County Fair & Rodeo, Inc. Executive Committee.
10. Lambs will be placed into classes of equal or near equal numbers, according to weight. The number of classes will be determined according to the number of entries at check-in. An exhibitor having two lambs whose weight would place both lambs into the same class must place the lamb with the heavier weight into the next higher class. If both lambs are placed into the heaviest class, an eligible stand-in exhibitor may show the lamb.
11. The top five (5) lambs in each class will be re-weighed. Animals having more than a maximum weight gain of five percent (5%) over the official weight at check-in will be sifted and disqualified.
12. A Proof of Delivery Form (when applicable) and thank you card (see General Rule #44) will be required before Exhibitor's check can be released. All exhibitors must come to the Fair Office, with these items, to sign for their check.
13. **ALL JR AUCTION AND COMMITMENT ANIMALS GOING TO THE PACKING HOUSE MUST BE RETURNED TO THE FAIRGROUNDS ON SATURDAY, MAY 1, 2021, AT THE DESIGNATED TIME.**

Fair officials reserve the right to change the rules, dates, times and places due to unforeseen circumstances.
