COOKIES FOR SANTA CONTEST RULES

Date: Saturday, December 2, 2017

Drop off Time: 11:30 a.m. - 12:30 p.m.

Place: Galveston County Fairgrounds Youth Building

Entry Deadline: Monday, November 27, 2017 by 5:00 p.m.

Entry Fee: \$5.00 per entry

An entry will consist of 2 DOZEN COOKIES.

1. The contest is open to children. Pee Wee (4-8), Sub-Junior's (9-12), Junior (13-17).
2. Amateur bakers only. No professional bakers can enter this competition. (A professional is defined as someone who works for a bakery, works for or owns a catering company or sells cookies).
3. Each contestant must submit a completed entry form along with entry fee. A separate entry form must be completed for each cookie entered. Entries will be accepted through Monday, November 27, 2017 at 5:00 p.m.
4. A recipe must accompany your plate of cookies. All recipes must be turned in complete with ingredient list, with the recipe name and contestant name.
5. Cookies must be sweet. Cookies can be frosted or decorated. Entry must be on a disposable cookie plate. Cookie plates will not be returned.
6. Cookies must be prepared and baked by the individual submitting the cookie entry for judging.
7. Please do not write your name on the cookie plate. Your entry will be assigned a number at registration to allow for anonymity during judging.
8. Cookies must be dropped off between 11:30 a.m. and 12:30 p.m. on Saturday, December 2, 2017 at the Galveston County Fairgrounds Main Entrance. (#10 Jack Brooks Park, Hwy. 6, Hitchcock, Texas 77563).

**NO NEW ENTRIES WILL BE ALLOWED THE DAY OF THE CONEST
NO COOKIES WILL BE ACCEPTED AFTER 12:30 P.M.**

JUDGING

1. Each plate of cookies will be judged on the following criteria:
 - *Overall appearance: creative detailing, etc.
 - *Overall flavor: fresh taste, texture, doneness, consistency, etc.
 - *Originality: creativity in appearance and flavor.
2. The decision of the judges is final. Judges will not know participants names.
3. Judging starts at 1:00 p.m. sharp.
4. The winners will be announced immediately following the close of judging.
5. At the end of the awards, cookies maybe purchased by making a donation to the Galveston County Fair & Rodeo, Inc.
