

**2019 Galveston County Fair and Rodeo**  
**Youth Steer Saddling Contest**  
**Rules and registration**

**Registration:**

1. Galveston County Fair and Rodeo will hold a youth steer saddling competition during the rodeo performances on April 4<sup>th</sup>, 5<sup>th</sup> and 6<sup>th</sup>, 2019.
2. The competition is open to High School students from Galveston County between the ages of 15 and 18.
3. All contestants and their parent must sign a release waiver.
4. Minimum of 6 teams entered, maximum of 12 teams.
5. 4 team members per team, from the same school.
6. No entry fee! 1<sup>st</sup> come - 1<sup>st</sup> serve.
7. Contestants will not be charged a gate fee to enter the Fairgrounds at the rodeo arena gates. This only applies to contestants; family members and friends will have to pay admission.
8. **Teams must sign up with the Fair office no later than March 19, 2019.** All required documentation must be turned in by this date or the team(s) will be disqualified.
9. 1 half of the entered teams will perform on Thursday night, the 2<sup>nd</sup> half on Friday night with the top 3 teams from each night coming back for the finals on Saturday night.
9. (a) Performance nights are chosen by draw and Teams will be notified the night of the draw. Due to school scheduling conflicts, Teams may request to change their night (if possible). Please contact the Fair office with any conflicts within 24 hours of notification, as we will have to contact other Teams to see if a move is possible.
10. The Galveston County Fair and Rodeo Committee reserves the right to open this event to out of County schools if 5 days prior to the event it is not filled to the maximum of 12 teams.
10. (a) should an out of County team(s) be needed, all registration and general rules apply as stated herein.
11. Buckles will be awarded to the 1<sup>st</sup> place team.

**Rules:**

1. Numbers will be assigned to each bucking chute and there will be a random draw prior to the event by the team captains after the team meetings to determine what chute you will have.
2. A steer will be loaded in the bucking chute for each team by random draw.
3. The steer will have a rope halter and lead rope put on at the time it is loaded.
4. All 4 contestants from each team must participate.
5. 2 team members shall mug the steer (hold in place by any means necessary) by using the lead rope, tail etc.
6. The 3<sup>rd</sup> team member shall put the saddle on the steer and secure it the best way possible or help mug if needed.
7. The 4<sup>th</sup> team member shall then ride in the saddle on the steer across the finish line for a time, in the case of 3 team members being needed to mug the 4<sup>th</sup> team member is responsible for saddling the steer.
8. No other team member may touch the saddle or the rider once they have mounted.
9. The non-riding team members may lead, pull or push the steer in an attempt to cross the finish line as long as the rider or saddle are not touched.
10. The rider must be mounted at the time the finish line is crossed or the steer must be lead back across the line and the rider will attempt to ride across again as many times as needed within the time limit. No time will be given unless the rider is on at the time the line is crossed.
11. There will be a 2 minute time limit.
12. Teams must furnish their own saddle.
13. There will be no use of hot shots or belts by competitors or arena workers to try and help move a steer.

**Tie breakers:**

1. in the event of a tie the arena judges have the final call
2. in the event there are no recorded times, the arena judges will make selections to move on to the finals.

**All entries and release/liability forms MUST be turned into the Fair office by March 19, 2019.** This can be done by dropping off at the Fair office or by mail. Contact Melondy Bender at the Fair office for Entry or Release/Liability form questions.
