Events:

Reindeer Tree Race

1. Contestant will start and end the event at a determined start/finish line.
2. Contestant will ride a stick reindeer/bouncy reindeer, provided by the event, through a tree pattern.

Reindeer Ribbon Pulling

1. Contestant will start and end the event at a determined start/finish line.
2. Contestant will begin at the start line and run or walk down to a reindeer with a ribbon on the animal.
3. The contestant must remove the ribbon from the animal and run or walk back to the finish line.

Wagon Snowball Hauling

1. Contestant will start and end the event at a determined start/finish line.
2. Contestant will begin at the start line and pull a wagon, provided by the event, and load it with the snowballs.
3. Once the snowballs are loaded, the contestant will pull the wagon back to the finish line.
4. All snowballs should remain on the wagon until the finish line is crossed.

All contestants will receive a gift bag for participating.
