2. The parade is open to walking and riding entries including bicycles, tricycles, wagons, strollers & pedal powered tractors/toys. Absolutely no motorized or battery operated riding apparatus is allowed.
3. Leashed pets with proof of current rabies vaccinations are welcome. Pets are not allowed in the buildings on the grounds. You are responsible for the handling of and for cleaning up after your pet – if they poop, please be kind and scoop.
