<b>LOCATION:</b>	<b>Fair Office, Jack Brooks Park</b>
<b>CROWNING:</b>	<b>Saturday, April 17, 2010 at 6:45 pm in the Rodeo Arena</b>

1. The Galveston County Fair King Contest is open to all boys who meet the following requirements:
  - a. are registered in the 9th thru 12th grade of a public or private school in and are members of a Galveston County 4-H or FFA Chapter;
  - b. is not a former Fair King of Galveston County Fair;
  - c. is single and has never been married;
  - d. has a project entered in the Galveston County Fair through 4-H or FFA, including:
    1. an animal project(s) (Livestock entries due January 27, 2010)
    2. OR has eight (8) items entered in the Youth Project Show (Project Show entries due March 11, 2010)
    3. OR an animal project and Youth Project Show entry
  - e. candidate must be willing to represent the GCF&R at official activities.  
**Example:** speak at 4-H meetings, support group functions, community activities and or benefits
2. Each contestant must meet the eligibility requirements set by their school. A Declaration of Eligibility Form will be sent to the contestant's school for verification of eligibility. Eligibility Forms will be handled by the Fair Office. You will be notified by the Chairperson if you are **not** eligible to compete. Refer to GCF&R Eligibility Rules.
3. Each Fair King is responsible for getting their own sponsor and sending a thank you note of which the chairperson will mail out once addressed and stamped. **THE ENTRY FEE IS \$50.00** which is to be paid by a sponsor. The deadline for entry forms and entry fees will be **THURSDAY MARCH 11, 2010, BY 5:00pm IN THE FAIR OFFICE. NO ENTRY FEES OR FORMS WILL BE ACCEPTED AFTER THIS DEADLINE. NO REFUNDS FOR ANY REASON. ALL RULES WILL APPLY AS OF ENTRY FORM DUE DATE.**
4. A narrative and essay are to be completed by each contestant. Each contestant must attach a 3 x 5 photograph to their entry. This photograph will be published in promotional materials for the fair.
5. All contestants are **required** to ride in the Parade on **Saturday, April 10, 2010**, to "kick off" the Fair. Contestants should assemble at 8:00 a.m. at the West County Building parking lot. Western wear will be the attire for the parade. You are not required to provide your own vehicle, a vehicle will be provided for all contestants to ride in.

6. There will be a parents/contestants' meeting on **Monday, March 29, 2010, at 7:00 p.m.**, at the Fair Office. **ATTENDANCE MANDATORY. (Exception - Death, illness or UIL Function. Chairperson must be notified in advance in order to be excused.)**
7. A private interview with the judges will be held on **Tuesday, April 6, 2010**, with assigned times beginning no later than 7:00 p.m. Western wear will be the attire for the interview. Contestants will be judged on poise 10%, personality 10%, appearance 10%, projects and achievements 10%, participation of shows and scheduled work hours 10% and essay, questions and interview 50% extra points will be given for non-scheduled working of shows or events during the fair. The crowning of the King and his Court will be on **Saturday, April 17, 2010** at 6:45 pm in the Rodeo Arena.
8. All contestants will be furnished with a schedule of events and dates. **All contestants are required** to be at designated events during the Fair. The designated events will be determined by the Fair King Chairperson. A form will be provided and must be completed to show times and must be verified and initialed by each show chairperson. **The King and his court are required to ride in the Grand Entry at the Rodeo on Saturday night.** If you are unable to attend any scheduled event, Chairperson must be notified immediately.
9. The decision of the judges is final. Under no circumstances shall contestants attempt to contact the judges before or after entering contest.
10. Each contestant will receive a gift. The King will receive a belt buckle. The Kings Court will receive awards depending on the number of contestants entered.
11. The contestants will vote for a Mr. Congeniality. This should be the boy who is always happy, helpful, and never complains. Mr. Congeniality will receive a plaque. Contestants are not allowed to vote for themselves.
12. Each participant is **required** to sign an Emergency Medical & Indemnity Form attached to the Entry Form. Failure to complete these forms will result in disqualification.
13. All contestants are **required** to wear their badges at **ALL** times on the Fairgrounds **EXCEPT** during any show in which you participate as an exhibitor. Badges will be provided for all contestants.
14. The Fair King will be responsible for attending at least three (3) events within the County during their current reign. Coordination **MUST** be made or approved through the chairperson prior to the events they request to participate in. Ex. Speaking at 4-H meetings, support group functions, community activities, or volunteering at local benefits.
15. ***A No Tolerance policy will be enforced. Each contestant must set a good example for their peers. A POSITIVE ATTITUDE AND BEHAVIOR IS A MUST. Remember you are representing your family, 4H, FFA, school, city, county and the Galveston County Fair & Rodeo. Absolutely no unsportsmanlike conduct. FAILURE TO COMPLY WITH THIS RULE MAY RESULT IN DISQUALIFICATION FROM PARTICIPATION IN THE GALVESTON COUNTY FAIR & RODEO, INC. FOR THE FAIR YEAR IN WHICH THE VIOLATION OCCURS AND THE EXHIBITOR WILL FORFEIT ALL AWARDS AND/OR PROCEEDS***
