AGES:	All Ages: Sub-Junior (8-12), Junior (13-17), Senior (18 & Up)
ENTRY FORMS:	Entry forms are due in the Fair Office by 5:00 p.m. Tuesday, November 28, 2023
DROP OFF:	All Crock Pots must be dropped off by 10:00 am to 10:30 am at the Country Store in Ed Pickett Memorial Hall (NO LATE ENTRIES)
JUDGING:	Saturday, December 2, at 11:00 a.m.

1. AMATEUR Cookers only! NO PRO's, restaurant owners or caterer's
2. Each contestant must submit a completed entry form along with fee for each entry.
3. A recipe must accompany your chili, with an ingredient list on the official recipe sheet (attached). Do not put your name on the crock pot, a number will be assigned to you for judging.
4. Chili must be prepared at home in Crock Pot and use a crock pot liner and must be warm at check in.
5. All entries will be judged on the following: Overall appearance, recipe creativity, freshness, flavor (spices) originality.
6. The Decision of the judges will be final! Entries will be Anonymous!
7. Judging begins promptly at 11:00a.m. SHARP!!
8. Winners to be announced immediately following judging.
9. Contestants must pick up crock pot immediately following the awards.
