PIE BAKING CONTEST RULES

Date: Saturday, December 2, 2023.

Drop off Time: 11:30 a.m. - 12:30 p.m.

Place: Galveston County Fairgrounds Youth Building

Entry Deadline: Tuesday, November 28, 2023, by 5:00 p.m.

Entry Fee: \$5.00 cash per entry

1. The contest is open to children and adults. Sub-Junior's (8-12), Junior's (13-17) and Senior (18 & over).
2. Amateur bakers only. No professional bakers can enter this competition. (A professional is defined as someone who works for a bakery, works for, or owns a catering company or sells pies).
3. Each contestant must submit a completed entry form along with entry fee. A separate entry form must be completed for each pie entered. Entries will be accepted through Tuesday, November 28, 2023, at 5:00 p.m.
4. A recipe must accompany your pie. All recipes must be turned in complete with ingredient list, with the recipe name and contestant name.
5. Pies must be sweet. You can make a cream pie but note, there will not be refrigeration available.
6. Bake in a disposable 8" or 9" pie tin or plate. Pies and pie tins will not be returned.
7. Pie must be prepared and baked by the individual submitting the pie entry for judging.
8. Please do not write your name on the pie tin. Your entry will be assigned a number at registration to allow for anonymity during judging.
9. Pies must be dropped off between 11:30 a.m. and 12:30 p.m. on Saturday, December 2, 2023, at the Galveston County Fairgrounds Main Entrance. (#10 Jack Brooks Road, Hwy. 6, Hitchcock, Texas 77563).

NO NEW ENTRIES WILL BE ALLOWED THE DAY OF THE CONEST.

NO PIES WILL BE ACCEPTED AFTER 12:30 P.M.

JUDGING

1. Each pie will be judged on the following criteria:
 - *Overall appearance: crust and filling color, creative detailing, even distribution of filling, etc.
 - *Overall flavor: fresh taste, texture, doneness, consistency, etc.
 - *Originality: creativity in appearance and flavor
2. The decision of the judges is final. Judges will not know participants names.
3. Judging starts at 1:00 p.m. sharp.
4. The winners will be announced immediately following the close of judging.
5. At the end of the awards, pies will be sliced, and the public may sample a piece of pie by making a donation to the Galveston County Fair & Rodeo, Inc.
